Natural Gas Supplier Information	North American Power & Gas, LLC (NAP) 888.313.9086 www.napower.com NAP sets and is responsible for the generation supply prices and charges that you pay.
Natural Gas Price Structure	<p><b>FIXED RATE.</b> Rate excludes State sales tax and county taxes, utility distribution charges and any applicable fees/charges.</p> <p>After the Fixed Price Period, the price will automatically change to a Monthly Variable Rate, which will be posted on the Customer's monthly bills from the Customer's Local Utility. There is no cap on the Customer's Variable Rate.</p> <p>The Variable Rates may increase or decrease at NAPG's sole discretion. The Variable Rate will be determined by NAPG based on business and market conditions including, but not limited to, the costs incurred by NAPG to procure natural gas to serve your account, transportation costs, balancing fees, storage charges, administrative costs, costs to acquire, marketing costs, profit, applicable taxes, and other business and market considerations. Customer's monthly Variable Rate may be higher or lower than the price offered in the initial or any prior month.</p>

Contract Start Date	Customer start date is based on when the Local Utility deems the switch effective.
Contract Duration/Length	Fixed Price Period of 12 months.
Cancellation/Early Termination Fees	\$10.00 per each month remaining in the Fixed Price Period.
End of Contract	Upon completion of the Fixed Price Period, this Agreement will automatically continue at the then-available Variable Rate on a month-to-month basis at the same terms, until it is cancelled either by you or NAPG in accordance with the terms of this Agreement. You will receive two separate notifications (each, a "Renewal Notice") from us in each of the last two bills for natural gas supply service charges or in corresponding separate mailings that precede the end of your Fixed Price Period. These Renewal Notices will explain your options going forward. Unless you notify us that you do not want to review this Agreement in writing or by calling us no later than 30 days after the date you receive the second Renewal Notice, you will be deemed to have irrevocably and unconditionally agreed to review this Agreement on a month-to-month basis on the terms and conditions set forth in the Renewal Notice. There are no early termination fees if you cancel after continuing onto NAP's Variable Rate.
